4	"(4) Nutrition education clearing-
5	House.—The Secretary shall make available to all
6	State agencies through an online clearinghouse any
7	nutrition education and training materials related to
8	nutrition for individuals impacted by a substance use
9	disorder or neonatal abstinence syndrome that have
10	been produced by the Secretary or the Secretary of
11	Health and Human Services (or produced by a State
12	agency and approved by the Secretary), including
13	educational materials developed under paragraph
14	(15) of section 515(b) of the Public Health Service
15	Act (42 U.S.C. 290bb-21(b)) and guidance issued
16	under section 1005 of the SUPPORT for Patients
17	and Communities Act (42 U.S.C. 1396a note).
18	"(5) Authorization of appropriations.—
19	There are authorized to be appropriated to carry out
20	this subsection \$1,000,000 for fiscal year 2020, to
21	remain available until expended.".
