**A BILL**

To amend the Public Health Service Act to direct the Secretary of Health and Human Services, acting through the Assistant Secretary for Mental Health and Substance Abuse, to award grants to eligible crisis centers to provide follow-up services to individuals receiving suicide prevention and crisis intervention services, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “CONtinuity in Nec-  
3 essary Evaluative Crisis Treatment Act of 2022” or the  
4 “CONNECT Act of 2022”.

5 **SEC. 2. GRANTS FOR FOLLOW-UP SERVICES TO INDIVID-**  
6 **UALS RECEIVING SUICIDE PREVENTION AND**  
7 **CRISIS INTERVENTION SERVICES.**

8 Title V of the Public Health Service Act (42 U.S.C.  
9 290aa et seq.) is amended by inserting after section  
10 520E–4 (42 U.S.C. 290bb–36d) the following:

11 **“SEC. 520E–5. FOLLOW-UP SERVICES TO INDIVIDUALS RE-**  
12 **CEIVING SUICIDE PREVENTION AND CRISIS**  
13 **INTERVENTION SERVICES.**

14 “(a) IN GENERAL.—The Secretary, acting through  
15 the Assistant Secretary, shall award grants to eligible cri-  
16 sis centers to provide follow-up services to individuals re-  
17 ceiving suicide prevention and crisis intervention services.

18 “(b) ELIGIBILITY.—To be eligible to seek a grant  
19 under this section, a crisis center shall be a member of  
20 the network of crisis centers coordinated under section  
21 520E–3(b)(1).

22 “(c) SELECTION.—The Secretary shall select recipi-  
23 ents of grants under this section based on the relative  
24 needs, including capacity and service gaps, of the eligible  
25 crisis centers applying for such grants.

1       “(d) TECHNICAL ASSISTANCE.—The Secretary shall  
2 provide technical assistance to recipients of grants under  
3 this section regarding best practices for the implementa-  
4 tion of services through such grants.

5       “(e) USE OF FUNDS.—

6           “(1) IN GENERAL.—A crisis center receiving a  
7 grant under this section shall use the grant to pro-  
8 vide follow-up services to individuals receiving sui-  
9 cide prevention and crisis intervention services such  
10 as—

11           “(A) individuals who were callers at risk  
12 of, or on behalf of someone at risk of, suicide  
13 or a mental health or suicidal crisis; and

14           “(B) to the extent possible, individuals  
15 who—

16           “(i) received a response from a mobile  
17 crisis team; or

18           “(ii) made a visit to an urgent behav-  
19 ioral health clinic, a crisis receiving and  
20 stabilization facility, an emergency depart-  
21 ment, an inpatient unit, or another short-  
22 term crisis care site.

23           “(2) FOLLOW-UP SERVICES.—Follow-up serv-  
24 ices referred to in paragraph (1) may include—

1                   “(A) check-ins to assess wellbeing and level  
2                   of risk;

3                   “(B) outreach to ensure engagement in  
4                   services and supports, in coordination with mo-  
5                   bile crisis service providers if involved;

6                   “(C) collaboration with family, caregivers,  
7                   and natural social supports; and

8                   “(D) referrals based on the needed level of  
9                   care.

10           “(f) AUTHORIZATION OF APPROPRIATIONS.—To  
11 carry out this section, there is authorized to be appro-  
12 priated \$30,000,000 for fiscal year 2023, to remain avail-  
13 able until expended.”.
